

Heal the Bay Cirque du Soleil Ticket Drawing Official Rules

Heal the Bay and Cirque du Soleil are the sole sponsors of Heal the Bay's Cirque du Soleil Ticket drawing and are solely responsible for the promotion and the ticket prizes associated.

1. How to enter: No purchase or Internet access necessary. A purchase will not increase your chances of winning. The Cirque du Soleil Ticket Drawing ("drawing") begins at midnight Pacific Standard Time (PST) on Monday, Feb 6th and ends at midnight PST on Friday, March 9th ("entry period"). There are two ways to enter: online or by mail. To enter online, go to http://www.healthebay.org/SMPA_OVO. Follow the directions to answer one of five posted questions. Entrants must complete all data requested on the form. Heal the Bay must receive online entries by midnight March 9, 2012. Limit one entry per person. Incomplete entries are void.

You may also enter the drawing by printing your name, address, city, state, zip code, telephone number, e-mail address, and the words "Heal the Bay Cirque du Soleil Ticket Drawing" with the answer to one of the five posted questions on an 8.5-by-11-inch, letter-size piece of paper and mailing it to: Heal the Bay Cirque du Soleil Ticket Drawing, Heal the Bay, 1444 Ninth Street, Santa Monica, CA 90401. Mail-in entries must be received by March 9, 2012. Limit one entry per person. All entries become the property of Heal the Bay and will not be acknowledged or returned. Illegible, photocopied, or other mechanically reproduced entries are void.

Heal the Bay assumes no responsibility for lost, late, misdirected, stolen, illegible, mutilated, altered, damaged, incomplete, or postage-due entries or for any computer, online, telephone, cable, network, electronic, or Internet hardware or software malfunctions, failures, connections, availability, traffic congestion, or garbled or jumbled transmissions or service provider, Web site, or other accessibility or availability issues, unauthorized human intervention, or any other error, omission, or technical malfunction that may occur. Entrants shall be the authorized account holder of the e-mail address submitted at the time of entry. "Authorized account holder" is defined as the natural person who is assigned to an e-mail address by an Internet access provider, online service provider, or other organization (e.g., business, educational institution, etc.) that is responsible for assigning e-mail addresses for the domain name associated with the submitted e-mail address.

- 2. Eligibility: The drawing is only open to legal residents of the United States (excluding Puerto Rico, Rhode Island, and Tennessee) who are 18 years of age or older on the date the contest begins. Employees of Heal the Bay and Cirque du Soleil and their subsidiaries, affiliates, prize suppliers, and advertising and promotional agencies, their immediate families (spouses, parents, children, and siblings and their spouses), and individuals living in the same household as such employees are ineligible. The contest is governed by the laws of the United States and is subject to all applicable federal, state, and local laws and regulations. By participating, entrants agree to be bound by the Official Ticket Drawing Rules and the decisions of the judges, which shall be final and binding in all respects. The odds of winning depend on the total number of eligible entries received. Limit one pair of tickets per person, family, or household from the Heal the Bay and Cirque du Soleil-sponsored drawing. The winner will be notified via e-mail or phone.
- **4. Prizes:** Prizes and approximate retail value (ARV): Five (5) prizes: one pair of price level two (2) OVO tickets. Prizes valued at \$160. Prizes cannot be exchanged for cash and cannot be used in conjunction with

any other promotion. No substitution or transfer of prize permitted except as provided for at the sole discretion of Heal the Bay and Cirque du Soleil.

5. General conditions: The drawing winner grants Heal the Bay and Cirque du Soleil the right to use and publish his or her legal name and city of residence online and in print, or any other media, in connection with the drawing. Acceptance of a prize constitutes permission for Heal the Bay and Cirque du Soleil and their advertising and promotional agencies to use the drawing winners' names and likenesses for editorial, advertising, and promotional purposes without payment of additional compensation unless prohibited by law. By entering this drawing, the contestant agrees to the following Statement:

In any such dispute, the participant shall, under no circumstances, be entitled to claim punitive, incidental, or consequential damages or any other damages, including attorneys' fees, other than the participant's actual out-of-pocket expenses (if any) associated with participating in the contest, and the participant hereby waives all rights to have damages multiplied or increased.
